This is a voluntary partial reallocation. The CoC determined that this project would be reduced in consultation with the project on July 12, 2023. Final notification to the project was issued via email September 12, 2023. The project has consistently encountered challenges in raising bed utilization rates in several parishes (counties) due to a variety of factors and determined that funds may be better utilized elsewhere in the CoC's geography to meet higher levels of need.
